Haliburton Unveils One of Canada's Most Sustainable Commercial Buildings

To one thought they could do it: take twenty-one relatively inexperienced builders and one instructor, and construct an 1800 square foot commercial building in less than twenty weeks. Not just a typical commercial building, but one that is made of straw, sits on a rammed earth-bag foundation and is heated and powered by the sun.

No, this is not a new TV reality show. This is the first project of Fleming College's new Sustainable Building Design and Construction program, offered at the Haliburton Campus of Fleming College.

The students, led by Program Coordinator and straw bale builder, Chris Magwood, proved the skeptics wrong. They celebrated the successful completion of the building at an unveiling ceremony and open house that took place on Friday, August 26, 2005.

Unique in North America, Fleming College's new leading-edge certificate program offers students both theory and hands-on experience in sustainable building practices. The first project, the new home of the Haliburton 4Cs Food Bank and Lily Ann Thrift Store, is unconventional indeed. In fact, it's one of the most sustainable building projects ever undertaken in Canada.



The load-bearing straw bale structure is finished both inside and out with clay plaster, and unlike most buildings constructed today, it contains very little cement or concrete. The perimeter foundation consists of polypropylene sacks rammed with earth and a small amount of Portland cement. The interior floor is also made of rammed earth, insulated below and warmed by a solar heated radiant floor system. The building is designed for optimal passive solar gain, and is kept cool in the summer by its two-foot thick walls and passive ventilation.

The building produces its own electricity through a grid-intertied photovoltaic (PV) system, and heat and hot water from roof-mounted solar thermal panels supplemented by an on-demand propane boiler. Strategically placed, energy efficient

windows and sun tubes provide optimal natural lighting, reducing the need for electric lighting.

The new 4Cs Food Bank building is the result of a partnership between Fleming College, the Municipality of Dysart et al, and the 4Cs, a church based charitable organization that has been operating the Haliburton Food Bank since 1979.

Despite some initial skepticism over the unorthodox building style and success of the construction project, the community of Haliburton, the three project partners, and the Sustainable Building program student builders have proven that a little community spirit and a lot of hard work go a long way in achieving common goals. The building is located at 25 York St., Haliburton, ON, next to the Rails End Gallery.

Fleming Students Develop Arboretum Master Plan for Frost Campus

Ecosystem Management Technology students at Fleming College have developed an arboretum plan that will transform the grounds at the campus with four unique eco-sites.

The eco-sites envisioned are a Tall Grass Prairie, a Butterfly Garden, a Wetland and a Living Wall. In addition to these sites, the plan also calls for the creation of signs that recognize the diversity of trees on the campus as well as the planting of more trees each year.

The third-year students are part of a team called Students Educating Environmental Diversity and Sustainability (S.E.E.D.S.).

Working as a consulting firm, the students were able to combine their individual and team strengths within the organizational structure of a company.

Susan Coleman, head of media relations for S.E.E.D.S. says, "Together we will work towards our vision for a campus where learning takes place both within and beyond the walls of the school. We look forward to the hands-on learning and direct experiences with nature that this initiative will create for the Fleming College and Lindsay communities."

The Arboretum Master plan



links directly to Fleming College's new Five-Year Strategic Plan in which the college has set forth the goal of being known for its leadership position among Ontario's post-secondary institutions with respect to environmental programs and practices.



Career and Work Counsellor Program Update

Career and Work Counsellor is a two-year, full-time program that prepares students to work in the field of career development, assisting people to choose a career, make the school-to-work transition, change careers, find a new job or perform on the job. The program is one of only two such Ontario College Diploma programs available in Ontario.

Fleming College program faculty have been busy over the past year "renovating" this program to ensure that students will acquire the skills to keep pace with changes in the field of career development. Here's a sneak peak at some of the changes our faculty are working on in preparation for re-launching this program starting September 2006.

Tools of the Trade

More hands-on practice with assessment tools that help career

development practitioners to both know themselves better and to gain more expertise in identifying client interests, abilities and skills.

PD Pipeline

Participation in more career development conferences and seminars to expose students to the latest trends in the field and provide more networking opportunities.

Friends in High Places

Expand the Fleming College Alumni Mentorship program. Fleming College was the first to offer training in employment counselling in Canada, starting in 1987. Since that time, a growing number of our program alumni have become well-established in their careers. The Mentorship program, which was piloted in 2004-2005, matches first semester program students with an alumni mentor. Students have invaluable, direct access to up-to-the-minute experience about the profession, as well as guidance, encouragement and support from a current career development practitioner, throughout their college program of study.

Career on the Move

Longer term, a fast track option for graduates of relevant university or college programs is being considered. This option would enable these students to complete the program and obtain the Ontario College Diploma credential in just 3 semesters.


