Ensure payment is received by the Residence Life Office on or before the due date. **A late fee of \$75 will be charged to your account if the payment is received after June 4, 2012.** A \$30 fee for returned cheques will also be applied to your account.

Have you applied for OSAP to fund your education?

If you have applied for OSAP, you can defer the Frost Residence Fees & Residence Council Fee **ONLY**. Read the Frost Residence Fee Deferment Form carefully to see if you meet the requirements. The Fee Deferment Form will only be processed if it is accompanied by the amount specified in Payment Plan C.

Payment Options: *Choose one option*

Payment Plan A Students paying their residence fees in one payment by the due date.

- \$3,149.00** \$350 caution/key deposit + \$25 residence council fee + \$2,774 residence fee

Payment Plan B Students deferring residence fees until their OSAP dollars are received by Fleming.

- \$ 475.00** \$350 caution/key deposit + \$125 deferment fee, non-refundable
If you choose this option, you must complete the Fee Deferment Form
\$25 residence council fee + \$2,774 residence fee = \$2,799

If a student is on OSAP any tuition refunds that may result from a withdrawal cannot be redirected to pay outstanding residence fees. This is a Ministry policy.
